- 2. You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
- 3. Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 31/12/2027 to the Board.
- 4. Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution)Act, 1981 from the Board.
- 5. It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- 6. Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

Specific Conditions:

1. This CTE is issued to M/s Garima Enterprises, for the production of Polly Bag for Plant Nursery (With hole)- 30 Kg/Month & Tree Guard 5000 No/Month by using of Polly Bag for Plant Nursery-30 Kg/onth, MS. Flat Iron- 35000 Kg/Month, Angle Iron- 14000 Kg/Month & Net (Jali) 17500 Kg/Month as per requirement at Geo coordinate Lat. 27.5806930 & Long. 28.0810410 Vill. Tipras, Jalesar Road, Distt. Hathras without any wet process.

4. Its CTE valid for the production of Polly Bag for Polly Bag for Plant Nursery (With hole)- 30 Kg/Month & Tree Guard 5000 No/Month.

3. This Consent is valid for the Establishment of unit only. The industry can only manufacture products, at the rate of production as mentioned in consent to Establish order. In case of any change in production capacity, process, raw materials use etc. Industry will have to be intimate to the Board. For any enhancement of the above, fresh Consent to Establish has to be obtained from U.P. Pollution Control Board.

3. Industry shall ensure adequate plantation and green belt within its premises.

4. The domestic effluent shall be discharged into septic tank followed by soak pits.

5. The industry shall take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards with respect to noise.

6. Industry shall abide by directions given by Hon'ble Supreme Court, High Court, National Green Tribunals, Central Pollution Control Board and Uttar Pradesh Pollution Control Board for protection and safeguard of environment from time to time.

7. The industry shall provide adequate arrangement for fire fighting the accidental leakages/ discharge of any air pollutant/gas/liquid from the vessel, machinery etc. which are likely to cause fire hazard including environmental pollution.

8. Industry should be obtained the NOC from State Board for any change in manufacturing Process, Product & Production Capacity etc.

9. Industry should be compliance the Plastic Waste Rules, 2016.

10. Industry should be compliance the Construction & Demolition Waste Management Rules, 2016. 13. Proper House Keeping Should be Maintained inside the industry premises.

14. The industry shall adhere to general standards terms and conditions of Water/Air Acts and compliance of Environment standards as per Environment (protection) Act 1986.

15. In case of violation of above mentioned conditions or any public complaint the consent to establish (NOC) shall be withdrawn.

16. Industry should be compliance the Municipal Solid Waste Rules, 2016.

17. Industry should not be stored the raw material & others goods in open area.

18. Industry shall submit first compliance report with respect to conditions imposed within 30 days of issue of this permission.

19. Its CTE valid only for construction. Industry obtained the consent water & Air form State Board before the operation of its industry, without obtained the consent water & air industry not operated. 20. Industry should not used the Solid fuel like coal & wood etc. in processing.

21. Industry should be obtained the NOC from Fire Department within three month & provide its copy in this office.

22. The unit shall comply with the provisions of the U.P. Ground Water Act, 2019 & shall ensure to declaration source of water as an undertaking.

23. Industry shall abide by directions given by the Commission for Air Quality Management in the National Capital Region for the protection and safeguarding of the environment from time to time. 24. Knowingly making any false statement for obtaining CTE or compliance with the conditions

shall result in the imposition of criminal penalties as provided under section 42(g) of the Water Act or section 38 (g) of the Air Act.

25. The applicant shall allow the officials of Uttar Pradesh/Central Pollution Control Board and/or their authorized representative, upon the representation of credentials:

To inspect raw material stock, manufacturing processes, reactors, premises, etc to perform the a. functions of the Board.

To enter upon the applicant's premises where an effluent source is located or in which any b. records are required to be kept under the terms and conditions of this consent.

To have access at reasonable times to any records required to be kept under the terms and c. conditions of this CTE.

26. This CTE is transferable, in case of a change of ownership/management, and the addresses of the new Owner/ partner/directors/proprietor should immediately apply for the same.

The issuance of this CTE does not convey any property rights in either real or personal 27. property or any exclusive privileges, nor does it authorize any invasion of personal rights, nor any infringement of Central, State, or local laws or regulations.

48. The applicant shall submit such information, forms, and fees as required by the board not later than 180 days prior to the date of expiration of this CTE.

49. The unit shall establish a separate environmental cell, headed by a responsible officer of the unit GARIMA EN I EN I EN A STOLE

for reporting environmental compliances.

50. The unit shall provide safety measures such as Helmets, Gumboots, Goggles, Masks, etc. to the workers for their safety.

51. This CTE order is being issued with the intention that no pollution or land ownership dispute is pending and no such litigation is pending in any court, otherwise, the consent order will be deemed to be nullified.

52. The unit shall abide by directions given by the Hon'ble Supreme Court, High Court, National Green Tribunals, Central Pollution Control Board, and Uttar Pradesh Pollution Control Board for the protection and safeguarding of the environment from time to time.

53. The unit shall comply with the notifications issued under the Environment (Protection) Act, 1986 from time to time.

54. Nothing in this N.O.C. shall be deemed to neither preclude the institution of any legal action nor relieve the applicant from any responsibilities or penalties to which the applicant is or may be subjected under the provisions of the Water/Air Acts respectively.

55. All amendments/revisions made by the Board in the emission/stack height standards shall be applicable to the unit from the date of such amendments/revisions.

56. The unit shall install separate energy meters for its air pollution control device plant and maintain the record on a daily basis regarding the consumption of energy for the running and maintenance of the Air Pollution Control Device.

57. Proposed industry shall comply the directions/orders of TTZ authority, Hon'ble NGT, High Court & SPCB/CPCB.

58. The unit shall use only the CNG or LPG Gas for the operation of the D.G. Set. Unit Shall not use HSD & Other Restricted Fuels in the TTZ Area at any Cost.

59. The unit shall deposit a bank guarantee of Rs. 10,000/- with an affidavit, within 15 days for complying with the above conditions.

Please note that consent to Establish will be revoked, in case of, non compliance ot any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 30/08/2024 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
